**Summary Annual Report for the
AMERICAN CENTRAL BANCORPORATION 401K PROFIT
SHARING PLAN**

This is the summary annual report for the AMERICAN CENTRAL BANCORPORATION 401K PROFIT SHARING PLAN, EIN 37-0985153, Plan number 001 for the period January 1, 2023 to December 31, 2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits under the plan are provided by the following arrangements:

- Through insurance and/or annuity contracts
- By a trust

Plan expenses were \$852,060. These expenses included \$8,227 in administrative expenses, \$843,833 in benefit payments, and \$0 in other expenses. A total of 173 persons are participants in or beneficiaries of the plan at the end of the plan year, although some may not have earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$14,329,144 as of December 31, 2023, compared to \$12,704,976 as of January 1, 2023. During the year the plan experienced an increase or (decrease) in its net assets of \$1,624,168. This increase or (decrease) includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income (loss) of \$2,476,228, including employer contributions of \$384,067, employee contributions of \$763,191, gains or (losses) of \$0 from the sale of assets, and net earnings from investments of \$1,328,970.

The plan has a contract with MINNESOTA LIFE INSURANCE COMPANY, which allocates funds toward . Total premiums of \$0 were paid for the plan year ended December 31, 2023.
